## What Is Operation 36?

Operation 36 / OP36 is a **long-term family coaching program** designed to progress golfers towards shooting par or better for 9 holes. Golfers of ALL ages and abilities can join our local training community and begin progressing through the six levels of development.

Each golfer will be issued a profile in the OP36 APP where they can view objectives, log golf actions, track progress and connect with friends in the social activity feed.

The program is led by Director of Instruction, Janean Murphy, who uses the OP36 framework to provide the best environment to help golfers improve their game and achieve their goals.

In addition to academy classes all golfers start at Division 1 playing 9 holes from 25 yards from the hole. If you shoot a 36 or better, you progress back to Division 2 at 50 yards from the hole. Each Division is set at a different yardage. You will repeat the process until you have beat all 6 Divisions.

## Who is summer golf camp for?

Juniors golfers of **any skill level are welcome** to attend a summer golf camp class. The classes are co-ed and broken down by the grade the junior has completed in school as of June 1<sup>st</sup>. All classes are offered at the low \$25 per hour group rate special.

## How do I register my junior golfer?

**First**, select your location: Oakhurst GC or River Plantation GC. **Then**, look at the four offered classes to determine the day of week and time your junior will attend summer golf camp. **Last**, register your junior for class by returning the registration form and release waiver to the corresponding pro shop or emailing the registration form & release waiver to Janean at [golf@janeanmurphy.com](mailto:golf@janeanmurphy.com). *If your junior is in the Jan-May after-school program you do not have to turn in release waiver and emergency forms.*

## ASSUMPTION OF RISK AND RELEASE AGREEMENT

**Assumption of Risk:** As parent or legal guardian of participant, I am aware that the Activity involves inherent risks, dangers, and hazards that can result in serious personal injury or death. I am also aware that the facilities and/or equipment contain dangers and can cause serious injury or death. I and Participant hereby freely agree to assume and accept all known and unknown risks of injury arising out of the Activity including injury or death that results from the Janean Murphy Golf Academy or Oakhurst/River Plantation Golf Club's negligence, design of the facility and/or equipment, or from any third party.

**Release and Indemnity:** In exchange for the Janean Murphy Golf Academy (JMGA) and Oakhurst Golf Club (OHGC) or River Plantation Golf Club (RPGC) allowing the junior Participant to participate in the Activity, I and Participant understand and expressly acknowledge that we, on our own behalf and on behalf of the other members of our family, including spouse, parents, children, heirs, and assigns, release, discharge, waive, relinquish, covenant not to sue, indemnify and hold harmless from any and all claims, actions, demands, costs, liabilities, expenses or judgments whatsoever, including attorneys' fees and costs, the JMGA and OHGC/RPGC, its parent company, affiliated or subsidiary companies, and all their respective officers, directors, agents, contractors, employees, heirs, successors, assigns, volunteers and guests ("Released Parties") from all liability for any injury, death, loss or damage connected in any way whatsoever to participation in Activity that may result from the JMGA or OHGC/RPGC negligence or willful misconduct of any third party, design of the facility and/or equipment, whether arising either directly or indirectly out of participating in an event or activities or from any third party, whether on or off the OHGC/RPGC's premises and including any transportation. It is the intention of the parties hereto that I will indemnify and protect the JMGA, OHGC/RPGC and Released Parties from the consequences of acts or omission of the JMGA, OHGC/RPGC and Released Parties or any third party (including others who may be participating), who may have a claim or cause of action against the JMGA, OHGC/RPGC and Released Parties that arose by, through, or under Participant, in whole or in part.

**Property Loss:** All personal property brought to the Activity is brought at the sole risk of the Participant as to its theft, damage, or loss or injury to any other third party.

**Medical:** I give my consent to emergency medical care and transportation in order to obtain treatment in the event of injury, as the Club may deem appropriate. I agree to accept full responsibility for and to pay for the cost of medical care, transportation and any other incidental expenses due to health, accident, or failure to conform to rules and guidelines established by the JMGA, OHGC/RPGC and the person in charge of the Activity. I further agree to release and hold harmless the JMGA, OHGC/RPGC, affiliated or subsidiary companies, and all their respective officers, directors, agents, contractors, employees, heirs, successors, assigns, volunteers and guests, whether associated with the Activity or not, arising from and extending to any and all liability arising out of or in any way connected with such provision of medical or surgical treatment or transportation provided in the event of an emergency.

**Photograph Permission:** I give permission for the JMGA and OHGC/RPGC to use, without limitation, photographs, film footage, or tape recordings that may include participant's image or voice for purposes of promoting the JMGA and OHGC/RPGC's programs.

**Severability:** Any provision of the Release found to be invalid by the courts having jurisdiction shall be invalid only with respect to such provision or portion. The remaining provisions hereof, shall be construed and enforced to the same effect as if such offending provision thereof had not been contained herein.
